







In the course of the Survey 147 questionnaires were sent out, 28 of which were completed and returned. 19% Reply rate













Question 1:Do you have experience in using geoinformation regarding
Habitat Directive (Natura-2000)?









Question 3: In how many of your projects (in %) do you use geoinformation services (methods, tools, data) regarding Habitat Directive (Natura-2000)?









Question 8: Which experiences have you gained with user rights regarding Habitat Directive (Natura-2000)?









Question 9: Which experiences have you gained with availability of geodata regarding Habitat Directive (Natura-2000)?








Question 12: In which data formats do you have geoinformation regarding Habitat Directive (Natura-2000)?









Question 13: Which medium do you use to send information?


Question 13: Information distribution








Question 15: Which experiences do you have with data quality regarding of Habitat Directive?








Question 16: What sort of main data deficiency do you encounter (if you encounter deficiencies) regarding Habitat Directive (Natura-2000)


Most often mentioned:

- etc.







Question 17: Which experiences do you have with compatibility and different Data Formats regarding Habitat Directive (Natura-2000)?


Question 22: How up to date are your data regarding Habitat Directive (Natura-2000)?















Interest in EU-projects
